Always add RAPTURE® 4-0-4 to the spray tank first and allow to dissolve completely before adding other products. For best results, rinse RAPTURE® 4-0-4 through a strainer basket or premix it as a slurry in a separate container before adding to the tank. Rate of dissolution may be improved with the use of warm or hot water.
