DIRECTIONS FOR USE

RESURGE™ can be applied to all crops, including vegetable crops, row crops, field crops, trees and vines.

Use in air seeder, strip till or banded fertilizer equipment: For use alone or in combination with fertilizers in all crops. Apply 6-20 lbs./Acre. Broadcast Application: Apply 10-40 lbs. per acre. May be applied at any time of the year, but preferred applications would be combined with fertilizers, including manure-based fertilizer, being applied to the soil for the cropping

SUGGESTED DIRECTIONS

WARM SEASON GRASSES: 1-2 lbs/1,000 sq. ft. in early spring and late fall. Problem spots may benefit from additional applications.

COOL SEASON GRASSES: Use at 1-2 lbs/1,000 sq. ft. as a top-dress after aeration. Mix with sand media if possible.

TREES, SHRUBS, WOODY ORNAMENTALS AND BEDDING PLANTS: Ring 2-8 oz. around base of trees and shrubs. Use higher rates on larger species. Broadcast 1-2 lbs/1,000 sq. ft. into ornamental beds.
